#### 1 Respective responsibilities of the body and the auditor

Other matters not affecting our opinion which we draw to the attention of the authority:
The smaller authority has confirmed that it has not complied with the governance assertion in Section 1, Box 5, in respect of risk assessment but it has provided the appointed auditor with an adequate explanation for non-compliance and details of the actions necessary to address weaknesses identified. The internal auditor has also drawn attention to this issue in the completion of the Annual Internal Audit Report, and their detailed report. The smaller authority has rectified the situation since the year end.
