Minutes of a meeting of the Finance Committee of Kingsmead Parish Council held on Tuesday 2nd May 2023 at 7:30pm

The meeting started at 7.45pm.

270	Apologies No apologies were received prior to the meeting.		
271	Declarations of Interest No declarations of interest were made.		
272	Public Forum There were no members of public present.		
273	Minutes The minutes of a Finance Committee meeting held on Monday 5 th December 2022 were circulated prior to the meeting and were assumed to have been read. It was resolved to accept the minutes as being correct and they were duly signed.		
274	Financial Position To receive a YTD update of the Council's financial position.		
	The committee noted the report presented for "Bank – Cash and Investment Reconciliation as of 28 April 2023."		

275 Budget Review

275.1. To review the agreed budget for 2023-24 and to consider if any recommendations should be made to Full Council for changes to proposed spending.

It was resolved that the budget meets current requirements, and no changes are needed. The committee noted an underspend in the Coronation Event budget, and it was resolved that this could be transferred to the Christmas Event.

It was further resolved that a recommendation should be made to Full Council that the current Grounds Maintenance contract should be extended for up to 2-years (as per the specification of the contract). This reflects the improvements made by Countrywide and removes the need for the contract to be re-tendered at the end of this financial year.

275.2. To consider the movement of funds to an alternative bank account.

It was resolved to recommend to Full Council that £100,000 be moved from the Unity Trust account to the Nationwide 45-day account, in order to earn a good rate of interest. Monies would be moved back to the current account later in the year to fund council spending.

276 Procurement Review

To review a spend analysis for 2022-23.

Having reviewed the spend analysis for 2022-23, it **was resolved to consider** alternative contractors for carrying out "ad-hoc" works on grounds maintenance. It was further resolved that a specification for tree works should be agreed, and Cllr Reed will present a proposal at the next committee meeting.

277 Insurance

To review the current insurance arrangements and to agree the basis for renewal in 2023-24.

It was discussed and agreed that a valuation of all the Kingsmead assets needs to be completed before a decision can be made about making changes to the insurance arrangements. It was therefore resolved that competitive quotes should be sought for this year's renewal based on the current insurance cover. 278 Annual AGAR Return

To approve the DRAFT AGAR return with revised asset figures.

It was resolved to approve a revised Draft AGAR with revised asset figures.
